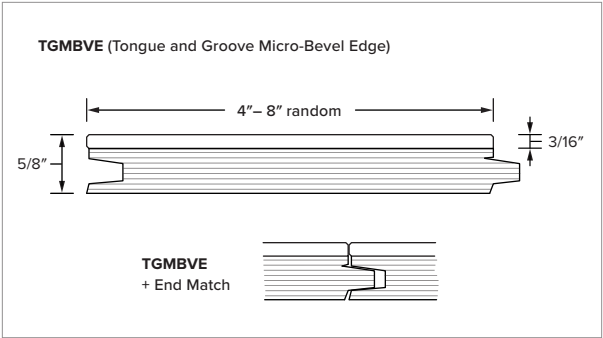




American Gothic White Oak

Heartwood:	No Restriction
Grain:	No Restriction
Knots:	No limitations on sound knots. <i>Surface defects from chipped or open knots may be present.</i>
Texture:	Surface should generally be 95% clear of saw marks or patina.
Voids:	Voids up to 1" in diameter will be filled with a black composite. <i>Insect marks, including pinholes, may also be present on the surface.</i>
Discoloration:	Ferrous staining from previous fasteners may be present.
Checks:	Structural checks not affecting the integrity of the plank, once installed, are allowed and more prevalent as the width of the material increases.
Moisture Content:	Kiln dried 6–9% prior to milling.

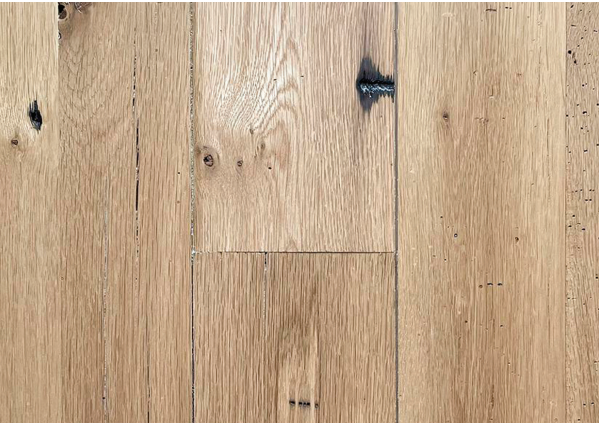
INSTALLATION RECOMMENDATIONS

Overage:	Minimum 10% additional material <i>for on-site grading, trimming and installation factors.</i>
Climate:	As with any wood flooring product, the room temperature should be held at a consistent range between 60-80° F with relative humidity between 30-60% . <i>Environmental conditions consistently outside of these parameters could result in product performance issues.</i>
