


Clear Vat Stock

Vinegar Vat Stock Patina & Center Cut: Batch #15091

Salvaged from vinegar vats, this material is primarily made up of Cypress and Douglas fir and is smooth planed, exposing the tight clear grain and the blondish-amber color tones of the wood.

Typically, 10–20% of these planks will include some dark staining.

Existing knots generally do not exceed 1/2" in diameter.

Checks: Structural checks not affecting the integrity of the plank, once installed, are allowed and more prevalent as the width of the material increases.

Moisture Content: Kiln dried 6-9% prior to milling.

INSTALLATION RECOMMENDATIONS

Overage: Minimum 10% additional material

for on-site grading, trimming and installation factors.

Climate: As with any wood flooring or paneling product, the room temperature should be held at a consistent range between 60-80° F with relative humidity between 30-60%.

Environmental conditions consistently outside of these parameters could result in product performance issues.




